## **Three-Generation Potential Matings With Resulting Inbreeding Levels**

You can use the table below to estimate the minimum level of inbreeding that will result from a potential mating. The top 18 Active and Foreign Al Bulls are listed across the top of the table. The far left-hand column lists the 32 most common sire-maternal grandsire combinations found in Registered Jersey females born since April 1, 2010.

Remember this is a minimum inbreeding level because it considers only the sire influence. Including the influence of the maternal line will increase the inbreeding values by 20% to 25%. Use JerseyMate to determine and manage the actual leval of inbreeding of these potential matings.
